# directions for use

**Dilution** Product can be diluted manually or through our proprietary dispensing units.

## Manual Dilution

Light Cleaning 1:16 (8 oz. per gal)
General Cleaning 1:8 (16 oz. per gal)
Heavy Duty Use 1:4 (32 oz. per gal)

**Automatic Dispensing:** Ask your Santec specialist for specific directions.

**Spray Bottle Space Sprayer:** Adjust nozzle to fine mist. Spray into four corners of the room.

**Contact Sprayer:** Spray *Laguna* on fabric or upholstery until it becomes slightly damp. Molecules will penetrate into the fabric and eliminate orders.

# PRECAUTIONARY STATEMENTS
