DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling. DIRECTIONS FOR SANITIZING AND DEODORIZING FOOD PROCESSING, DAIRY FARM, HOTEL, RESTAURANT AND TAVERN EQUIPMENT-IMMERSION METHOD: Prepare a sanitizing solution by thoroughly mixing in an immersion tank, add 2 oz. of Resolve Three with 10 gallons of water to provide approximately 200 ppm of available chlorine by weight.
